First Aid

It is essential that the supervising teacher of each class comes prepared with their own first aid kit and any medications that may be required for students under their supervision (e.g., an EpiPen, asthma treatment).

FEF staff carry a first aid kit at all times and will assist in injury requiring care, on request of the supervising teacher.

All staff have completed first aid training through the Australian Red Cross.

The cost of an incursion is \$50-\$75 per class.

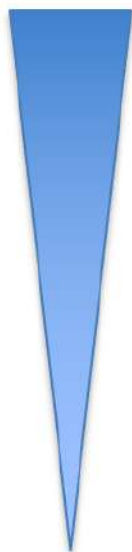

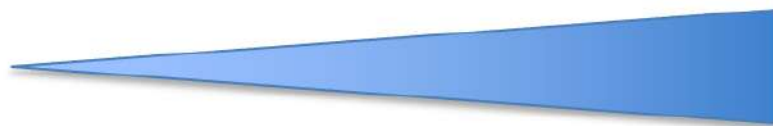


Probability- Likelihood

Low risk

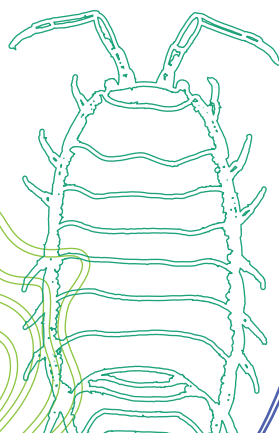
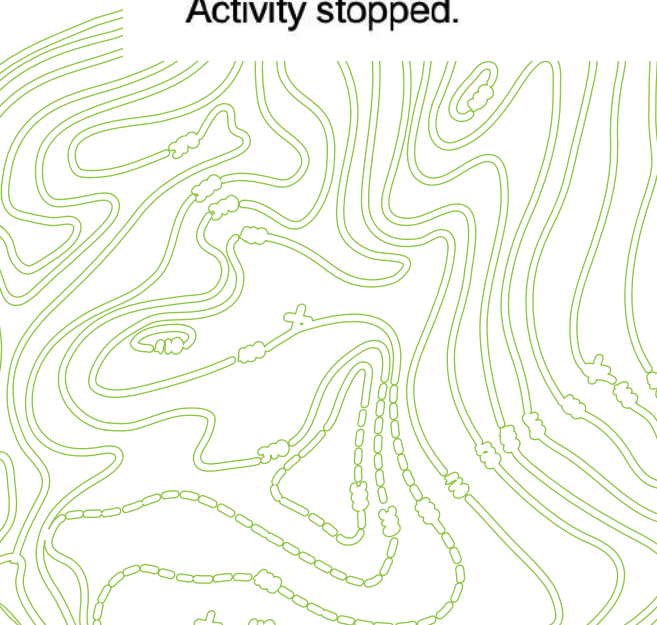
Medium risk

1	Splinters or small abrasions from wooden materials	B	1	B1	- Students supervised by school and FEF staff at all times - Clear instructions on handling of materials provided - First aid kit available in classroom/school office
2	Bumps or falls during movement activities	C	1	C1	- Students supervised by school and FEF staff at all times - Students instructed when physical space is required for an activity - Clear directions as to movement provided - School first aid procedure followed
3	Injuries from building activities	A	1	A1	- FEF educators to limit building activities to less than shoulder height of students - Building to be constructed on floor where possible - School first aid procedure followed if bumps and incurred
4	Bites/stings from insects brought in on vegetation (and possible allergic reaction)	A	2	A2	- Advise schools prior to incursion of activities included in program and natural materials being brought to site (bark, sticks, leaves, rotting log) - Inform the staff and students of potential bites and sting hazards prior to handling of materials - School to complete confirmation form prior to excursion, providing information on all known allergies - School staff inform FEF of any students with known allergies on arrival to site - FEF staff to maintain awareness of the presence of insects at all times - FEF staff maintain first aid training annually - First aid kit available in classroom/school office
5	Sun Exposure (Sunburn/Dehydration/hyperthermia)	A	1	A1	- Teachers to follow school sun safety procedure - Seek shade where possible to avoid extended exposure - FEF staff to ensure regular breaks if required during program - In cases of extreme heat, programs will be conducted indoors
6	General illness	B	1	A1	Monitor participants – program adjusted as necessary (e.g., teacher to attend and administer first aid)
7	Medical issues due to pre-existing medical condition	B	1	B1	- School to provide list and inform FEF teachers of any students with pre-existing medical conditions that could impact their ability to participate in FEF incursions - School to provide adequate first aid supplies
8	Safeguarding and disclosures	A	2	A2	- Students advised to remain as a group and maintain sight of school staff at all times - FEF staff to refer incidences of personal disclosures to school staff - School staff follow safeguarding procedure
9	Soil and plant pathogens	A	1	A2	- Students directed to wash hands after touching soil/decaying logs - Teachers to provide sanitiser to students if required
10	Transmission of communicable disease	B	2	B2	- Students to wash and sanitise hands as required - Students or staff with COVID-19 symptoms are not to attend - Adhere to government guidelines regarding Covid safe measures
